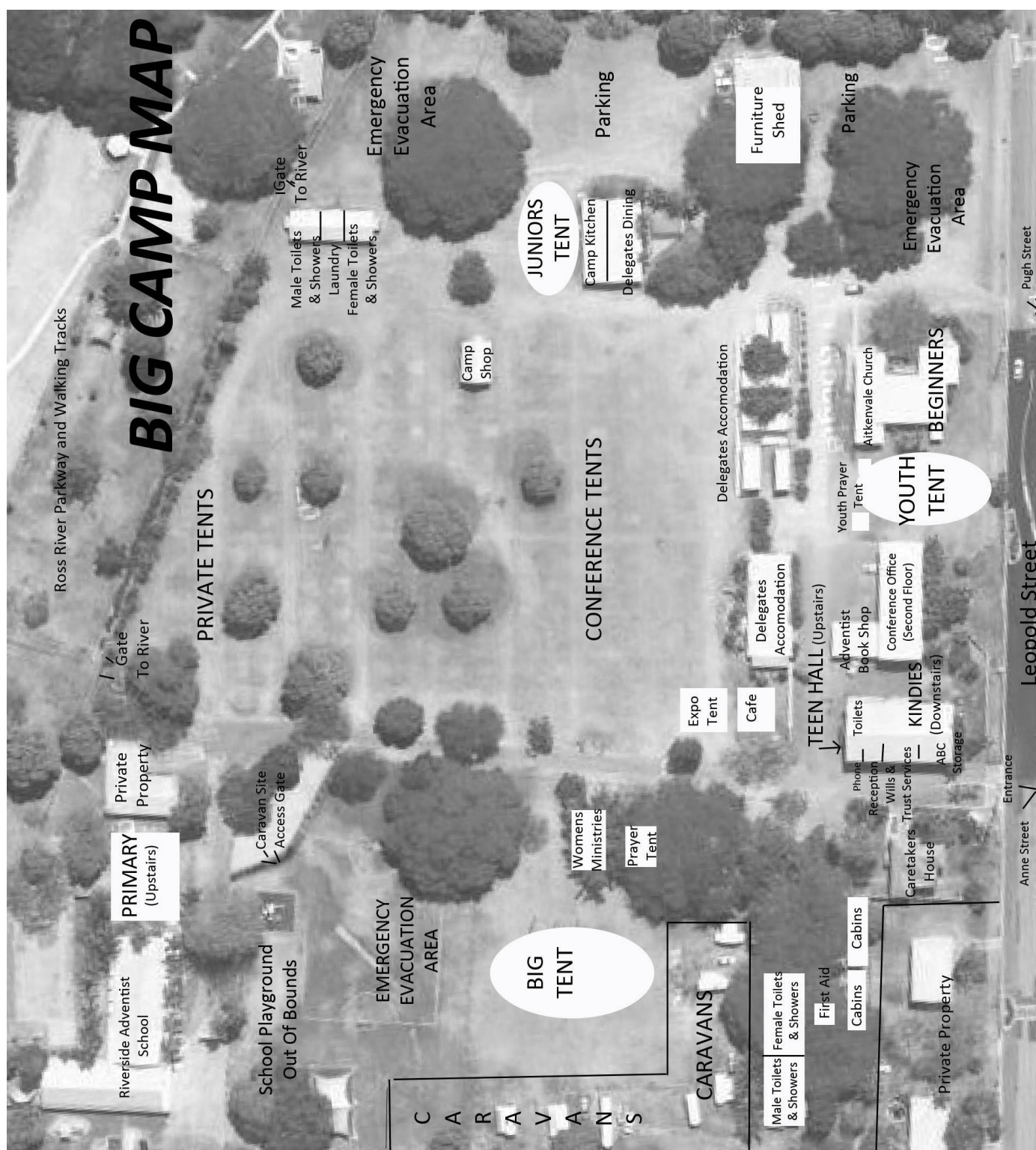

4. Activity Application Form

To participate in the full experience of camp children are encouraged to take part in all the activities. An Activity Application Form should be filled in by all those attending Primary (age 7 to 9), Junior (age 10 to 12), Teen (age 13 to 15) and Youth (age 16+). Activity Forms will be mailed out in the near future.

To save time at registration it is suggested that these forms be filled in and payment made prior to camp. Each child/youth that registers will receive a wristband which can be collected from the camp office.



5. Camp Information and Regulations

In the interest of the safety, comfort and welfare of all campers, the following information and regulations will apply. Please read carefully and seek clarification (if required) before signing your application form, which represents your agreement to abide by all these regulations.

B. ARRIVAL

The campground is open for registration from midday Thursday 23 June. **Everyone arriving must report to Registration** and receive their site allocation and registration details.

- Please note that all registered campers will be issued with wristbands.

C. ACCOMMODATION/SITES

There are three different types of accommodation/sites available:

- **Powered Caravan Site.** Powered connections must be an approved Residual Current Device (RCD). Campers must not alter or interfere with any electrical connection at any time if a problem arises.

It is imperative that the width and length of your caravan be stated on your application form so that an appropriate site can be allocated to you. Please note on your form if the side of your van extends out, or if you have a fifth-wheeler or motorhome,

Due to demand on caravan sites and our limited site facilities, preferential treatment will be given to Northern Australian Conference members up to the 13th May.

After this time, applications for van sites will be treated on a first-in/first-served basis from all applicants.

- **Unpowered Site** – Bring your own tent.

Conference Tent - NO POWER OR LIGHTS PROVIDED. The facility to provide light power in the Conference tents has been removed and therefore you will need to provide your own **battery powered light** for your tent. Gas powered lighting must not be used in any tent as this is a fire hazard.

D. FEES

- An accommodation/site fee is required as per application form. Payment for your site and/or furniture must accompany your application form.
- **The Early Bird Discounted Cost ends on the 3rd June, 2016.**
- We do not offer short term discounted periods of stay during camp. Our camp fee is a flat fee that applies for the whole or part thereof of the camp period.
- **A refundable Furniture Deposit is required to be paid when ordering any quantity of furniture. This deposit is refunded at the end of the camp when furniture is returned to the furniture shed.**
- To fully participate in camp it is encouraged that all children pay the activity fee for their division. If not paying the activity fee, meetings only can be attended with no participation in activities and/or crafts.

E. FACILITIES

Two ablution blocks are available, containing toilets and showers. There is one coin operated washing machine available in the ladies end of the eastern block. The western block also includes coin operated laundry facilities with each machine requiring 3 \$1 coins per load.

F. TELEPHONE

There is a coin operated phone available outside the camp office

G. WATER SUPPLY

Please note that the hot water supply is limited so please keep showers short and do not leave taps running.

H. RUBBISH DISPOSAL

It is every camper's responsibility to keep their camp site clean and tidy. Skip bins are located at central points around the campground as well as outside each ablution block.

I. MOVEMENT & PARKING OF VEHICLES

- Vehicle access to the grounds is limited during camp so please respect a closed barrier as an indication of no vehicle access.
- Access to any area of the Camp Ground is a privilege and directions given by Camp Staff are to be obeyed at all times.
- Observe all SPEED LIMITS posted. Failure to do so will result in the individual being banned from driving on the grounds.
- Car parking is in designated car parks only unless an exemption is supplied by the Camp Administration.

J. ALCOHOL & OTHER DRUGS:

As the Camp Ground is designated an alcohol, tobacco and drug free environment the following rules apply;

- Alcohol, tobacco and illicit drugs are not to be brought onto the Camp Ground. Offenders will forfeit their rights to be on the grounds.
- If it is found that alcohol, tobacco or illicit drugs are being consumed at a particular campsite then all occupants of that site will be required to vacate and forfeit all rights to the site, and will not be allowed to use the site again for the duration of Camp.

K. RESPONSIBILITY FOR CHILDREN

During the programmes, the camp staff will facilitate the activities. Outside of program times, children will be the responsibility of their own parents/guardians. Parents are also responsible for dropping off and picking up their children from their respective programmes. Parents need to know at all time; where their children are; what they are doing; and which adults are responsible for their supervision and safety.

L. CAMP REGULATIONS

- No one may sleep on the grounds unless they are a registered camper.
- Young people under 18 are not permitted to camp overnight without adequate adult supervision approved by the Camp Committee.
- Modest attire is to be worn in all public settings.
- Loud and offensive language is not accepted or tolerated.
- Children must not be left without adequate adult supervision at any time.
- Camp parking is in designated areas only.
- Noise levels are not to disturb other campers.
- Pets are not permitted anywhere on the grounds.
- Bicycles are not to be used on the grounds during camp.
- Valuables should be cared for and not left in tents or caravans unattended. Please ensure that you look after purses, wallets and mobile phones at all times.
- There is a camp curfew for all campers at 11.00 pm. This means that there will be a quiet down period from 10.00 pm and all campers should be in their elected accommodation site with lights off and no noise by 11.00 pm.

M. APPLICATIONS

Camp Administration reserves the right to accept or reject any application. No application will be accepted unless accompanied by full payment. The occupier of the site, who is to be the responsible adult, must sign the application form.

N. CANCELLATIONS
